Regular Session April 13, 2022

The Primghar City Council met in regular session on April 13, 2022, at 5:00PM in the council chambers with Mayor Kurt Edwards presiding. Council present – Tim Honkomp, Ryan Jenness, Ken Miller, Steve Wittrock, and Kevin Smith. Staff present – Carol Chicoine, Sarah Rohwer, and Mike Warnke. Motion by Honkomp, approving the consent agenda, approving April 13 agenda, council minutes from March 9, 2022 and March 25, 2022; library minutes from March 9, 2022, PGCC Golf Board Minutes from March 24, 2022 and March 25, 2022, Golf Course Board Members Robert Rushton (2025) and Drew Gifford (2025), and Rodd Holtkamp TCA Board. Second Jenness, all ayes, motion carried.

No written or oral citizens' concerns were received. Visitors: Pastor Mike Cooper from the Church of Christ presented to council that the church would like to build a Gaga Pit and donate that equipment to the City Park along the highway. Lynn Porter with Black Hills Energy came to give council an update on different community contributions that have been made. Contributions include being chamber members, sponsoring events like Scaritage Park and Cobblestone Days. Another issue that was highlighted was the Polar Vortex that occurred in 2021 and how Black Hills Energy is recouping the cost of that Vortex. From April 2021 to March 2023 there will be a line item on Black Hills bills that will go towards recouping the cost of the hike in natural gas prices during the Polar Vortex. Bruce Devereaux with the O'Brien County Sheriff's Office was in attendance to go over the FY 23 O'Brien County Sheriff Contract. The cost of the contract will increase from \$98,028.80 to \$104,039.49. Dennis Haselhoff with DGR Engineering was in attendance to give the results of the Generation Feasibility Study. Haselhoff outlined the four different options that DGR came up with during the Generation Feasibility Study and was able to answer questions that council members had.

Mike Warnke gave council an update on projects that the city workers have been working on: the water tower building has been painted and cleaned, cleaning out the airport hanger, cutting streets and getting them ready to pour, sweeping streets, someone needs to be brought in to vacuum out woodchips from Cell 1 at the lagoon, starting to drag gravel roads and alleys, and fixing a hydraulic leak on the grader.
